For products sold but not manufactured by Kitchen Magic, refer to the manufacturer's warranty, or visit <http://www.kitchenmagic.com/service/warranty>. Labor on all products is warranted for one (1) year from date of job completion. This is the entire agreement. No verbal agreements will be honored. This warranty is non-transferrable and activated upon receipt of payment in full. Kitchen Magic reserves the right to substitute and/or upgrade our products.

**Wood Product Warranty:** Kitchen Magic warrants that all wood doors, cabinet surfaces, and moldings are free from defects in materials and workmanship for a period of five (5) years. Natural characteristics such as mineral streaks, burls, grain patterns, etc. found in wood will not be considered defects unless otherwise specified by Kitchen Magic. Due to its inherent nature, wood will expand and contract in accordance with its environment. Therefore, Kitchen Magic does allow some wood movement. Final product color will be affected by the natural color and grain characteristics of the wood. Kitchen Magic is not responsible for variations in color tone among doors and drawer fronts or between a finished solid wood product and veneer. All other products manufactured by Kitchen Magic are warranted under reasonable home use and service for as long as you, the Buyer, own your home. For products sold but not manufactured by Kitchen Magic, refer to the manufacturer's warranty, or visit <http://www.kitchenmagic.com/service/warranty>. Labor on all products is warranted for one (1) year from date of job completion. This is the entire agreement. No verbal agreements will be honored. **Countertop Removal by Customer Disclaimer:** The Customer understands that, by taking on the responsibility of removing the existing countertops and/or appliances, Kitchen Magic will not be held accountable for any damage done in the process. The Customer also understands that it is their responsibility to make sure that the cabinetry is structurally sound and level to within 1/8" as required by the product manufacturer's installation specifications. If the services of Kitchen Magic are required for any work related to the above, it will be done at a reasonable additional cost as determined by Kitchen Magic. This work may include, but is not limited to, any of the following: Removal of existing countertop(s); Removal and/or reinstallation of existing appliance(s); Leveling of existing cabinetry; Removal and/or reinstallation of cabinetry; Securing of existing cabinetry; or, Installation of molding to cover gap(s).

The Customer has been shown a color and/or style sample of the material(s) that will be used by Kitchen Magic to complete the installation. The Customer understands that the material(s) is(are) not an exact match to the color and/or style of the existing kitchen but rather represent(s) the closest available match offered by Kitchen Magic. Therefore, Kitchen Magic is not responsible for variations in color and/or style between the installed material(s) and the existing kitchen.

**Vintage Series Doors Disclaimer:** The glaze on Vintage Series doors is a decorative overlay that is applied after the door is fabricated. Therefore, glazing can be removed by excessive scrubbing or the use of non-compliant cleaning agents. This is an inherent characteristic of glazed products, and they will not be replaced under warranty for inconsistencies in appearance that occur as a result of the above actions. Replacements can be purchased for a reasonable fee. Please refer to Kitchen Magic's Vintage Glazed Series care and maintenance instructions for a list of approved cleaners.
